

Ten Year Product Guarantee

Conditions of Warranty

Section 1: Definitions

1. "Company" shall mean Clear View Bi-Folding Doors Limited whose office is situated at Unit 18 Holme Mills, West Slaithwaite Road, Slaithwaite, Huddersfield, HD7 6LS.
 2. "Goods" shall mean all or any of the goods or materials which from time the company contracts to supply.
 3. "Services" shall mean all or any of the services which from time to time the company contracts to supply.
 4. "Purchaser" means the person, firm, company or other organisation who places an order with the company or otherwise contracts with the company for any goods or services.

Section 2: Application

1. These conditions shall apply to all contracts, whether written, oral or implied for the supply of goods or services.
2. Any conditions of purchase or other terms provided by the purchasers shall be of no effect whatsoever nor shall any variation or alteration of these conditions be of any effect unless made in writing and signed by or on behalf of the Company.
3. All guarantees/warranties contained in this document shall be for a maximum period of ten years from date of purchase and are only valid once payment has been received by the Company in full. Non – domestic installations are guaranteed for **one year**.
4. Frames and insulated sealed glass units are guaranteed to free from defects in material and workmanship for a period of Ten years, the glass units guarantee does not include breakages of any kind. Integral blinds carry a five-year guarantee and a two-year guarantee on external components.
5. Door and window furniture is guaranteed to be free of corrosion and tarnished* for a period of one year and is guaranteed to be operable for a period of ten years, subject to satisfactory regular maintenance by the customer.
6. Door locking systems and other operational gearing is guaranteed to be free from mechanical defects for a period of ten years, subject to satisfactory regular maintenance by the customer.
7. Guaranteed against any breach of the Building Regulations, caused by the installation work, in force at the time of the completion of the works for a period of 6 years
8. Valid proof of purchase must be shown to the Company before any request for remedial/repair/replacement work will be acknowledged.
9. The company will not entertain any request for remedial/repairs/replacement work where structural elements or fixings into brickwork need to be removed/replaced. Remedial/repair/replacement work will extend only to hardware and plastic components of the product(s) supplied by the company.
10. The Company reserves the right to recover costs from customer for labour time and travelling expenses where faults/damage are the result of installation which is not in accordance with the companies instruction and/or where repairs/replacements are found to be beyond the terms of this warranty.
11. All conditions contained in this warranty are subject to adequate maintenance of the goods supplied. The Company will not be held liable for repairs to or replacement of goods which are damaged due to misuse, negligence, deliberate and/or accidental damage whatsoever the cause, fire, flood or normal wear and tear.
12. All construction, validity and performance of this guarantee shall be governed by and interpreted in accordance with English Law.
13. This guarantee is transferable.

*Excludes chrome furniture where fitted externally and all finishes in coastal areas or other corrosive environments.
